Hereby states that we have read and understood the rules and conditions pertaining to the scholarship privilege as contained in this document, as follows:

- a) One-Grantee Per Family: Grantees of scholarships and other form of financial assistance, except for the Family Tuition Discount Privilege, can be given to only one individual per family.
- b) Academic Load: An AMA scholar must strive to have an acceptable academic load, wherein he/she is enrolled in all prescribed subjects for the school term being attended, including non-credit subjects if required.
- c) Obligations: All grantees must meet the academic standards required for their scholarship and must abide by the policies prescribed by AMA.
- d) Non-Transferable: Enjoyment of the scholarship or financial aid/grant is limited to the specific individual beneficiary and cannot be transferred to another person for whatever reason.
- e) Return-Service: All grantees may be required to render service/assistantship beginning their residency at any AMA school.
- f) Renewal and Documentation: The renewal of scholarships and financial-aid grants shall be every school-term and renewal requests will not be processed unless accompanied by required documents, including grade sheets without failing marks from last school term attended and an endorsement from a third-party benefactor, if required.
- g) Scholars' Term-Limit Rule: All AMA scholars of good-standing shall enjoy their educational privileges subject to a limit of not more than one and half times (1 ½) the normal term of study of their programs/courses.
- h) Leave of Absence: An AMA scholar who cannot enroll for any school term must file a must file a Leave of Absence (LOA) every enrollment in order to be avail the same scholarship privileges last enjoyed upon resumption of study, subject to standard scholarship renewal policies. However, an LOA cannot be filed for more than two years.

We further state that we agree and shall abide by the rules and conditions as stated herein and shall likewise abide to any other rules, regulations and conditions that the AMA Foundation, Inc. and AMA Education System may formulate in the future concerning all matters relating to the educational programs of AMA and our enjoyment of the scholarship and tuition fee discount privilege.
